#### Sarah Galliher, WRDSB Senior Planner

### Sue Simpson – Director of Waterloo Region Family Network

Watched video with overview of mission, values, mandate and strategic priorities of the organization. There has been growth each year with program support, workshops, conferences, camps, clubs and seminars. Network support is unique and inclusive of all needs with families and community contacts. Currently a gap in the ages of 12-16 years old with no programs listed. They are working to address this issue. Volunteers are required thus causing the lack in programs for this age group.

### Krista McCann – Program Coordinator of Waterloo Region Family

**Network** Overview of Young Carers Project wherein they educate the public about existence and needs of young carers. Watched video done by Young Carers Group. Examples of what Young Carers help with include physical, mental or personal care. Young Carers feel isolated, anxious, hard time focusing, they are overlooked and

dismissed by others. They want to be acknowledged and supported for what they are doing and going through. - Draft Policy/Program Memorandum 161: Supporting Students with Prevalent Medical Conditions
  - Emailed document which highlights anaphylaxis, asthma, diabetes, epilepsy. Policy covers a plan in place, medical safety plans done at schools.
  - Students, staff and principals responsible for plan of care.
  - Liabilities Ryan's Law and Sabrina's Law duty of care and privacy
  - Still in draft form and Ministry is looking at putting advisory councils together to provide feedback
  - Question about Student Safety plan and how this is related to IEP. At this
    time WRDSB is in the process of revising procedure 2303 with with the
    WRDSB Health and Safety Department as well the Joint Health and Safety
    Committee. This will make everything electronic and this information will
    be stored in a database, that meets all privacy requirements
