Attached to this report is a synopsis of the projects submitted by the 2016-2017 recipients of the Tim Walker Award for Environmental Stewardship. (Appendix A)

Background

In May 2006, the Board passed a motion to administer the Tim Walker Memorial Award for Environmental Stewardship annually to honour the life of secondary school teacher Tim Walker and his contribution to education and environmental initiatives. The annual award is \$2,000, which is to be equally distributed among two elementary and two secondary schools (i.e., \$500 per school). At a meeting on March 28, 2017, an adjudication committee reviewed the applications submitted for the 2016-2017 Tim Walker Memorial Award for Environmental Stewardship.

Financial implications

An amount of \$2,000 will be charged annually to the Trustee expenses budget (this action commenced in the 2006-2007 school year). This is the eleventh year the award has been issued.

2016-2017 Tim Walker Memorial Award for Environmental Stewardship

Project Synopsis

Elementary Award Recipients

J.F. Carmichael Public School – Pollinator Garden Creation: Phase 2

Pollinators are an essential part of our ecosystem. Taking action to support pollinator populations promotes a healthy, well-balanced ecosystem. Two years ago, Grade 6 students planted a pollinator garden. The garden is a circle covering an area of approximately 60 metres squared. It includes native perennial plants like Black-Eyed Susan, Columbine, Blue Rye Grass, Asters, Echinacea and Milkweed. These plants attract pollinators and support their populations. Funds from this grant would allow us to purchase more native plants to help increase their density and help the garden more quickly establish itself and win the battle against the weeds.

J.W. Gerth Public School – Stream of Dreams

Stream of Dreams is an eco-educational program, run in conjunction with the Grand River Conservation Authority, which teaches children about their local waterway, and the impact humans have on conserving and protecting our environment. The project started out west, when a girl noticed some fish had been killed from a company dumping pollutants in the local waterway. She wanted to have children from all over the world, be more knowledgeable about their waterways and become stewards for the environment. In the local program, the students get the opportunity to participate in a program that explores their local community waterways, find out what happens when pollutants are poured down drains or sewers and discover where their local drinking water comes from. At the completion of the project, each student will be given the opportunity to design and paint their own "dreamfish", which represents their hopes for their future. These dreamfish will be mounted on the fence surrounding the school year, in an artistic mural, that mimics the flow of wild salmon swimming.

Secondary Award Recipients

Huron Heights Secondary School – Food Forest

Our plan is to create a food forest, and in doing so, create a green space that supplements the nutritional and educational needs of students at Huron Heights Secondary School. A food forest is inexpensive and self-sustaining so it will be easy to implement and maintain on a reasonable budget. Our Food Forest will provide food for the school (e.g., Nutrition for Learning, Life Skills/Dev Ed Class and Family Studies courses) and greater community, provide a quiet place for mindfulness and reflection, improve the air quality of the area and provide students with additional greenery in the school space.

Jacob Hespeler Secondary School – Canada 150 Celebration Tree Dedication

We plan on dedicating **five trees that are native to Canada** to each class of this 2017 year (grade 9's, 10's, 11's, 12's and staff). Each grade will vote on their maple of choice through a google form. Choices will include: Red Maple (Canada's flag), Silver Maple, Sugar Maple, Big Leaf Maple, Douglas Maple, Black Maple, Striped Maple, Vine Maple, and Mountain Maple.

The trees will be labeled with a dedication plaque (through other funds) identifying the Canada 150 celebration, the "Tim Walker Memorial Fund", the class that the tree was dedicated to, the type of tree and identifying features of the tree indicating its native status. They will add to our ongoing habitat naturalization projects at JHSS. Several native trees have been planted on the front east side of the school property along with native wildflower gardens to increase the biodiversity on our school property. At present, there is minimal tree cover (only 4 mature trees) at the back of the school, alongside the sports fields that are shared with the City of Cambridge. Increasing tree cover globally is paramount in addressing and mitigating the impacts of climate change.

Dear Minister Hunter:

On February 21, 2017, Bluewater District School Board passed a motion to write to the Minister of Education requesting that the scope for the Special Education Funding Working Group be expanded to include a more robust and comprehensive review of both the current special education model as well as the funding of special education in Ontario as a whole. The board recommends that further consultation should include the following groups:

- Minister's Advisory Council On Special Education;
- Provincial Parent Advisory Association Committee On Special Education Advisory Committees;
- Special Education Advisory Committees;
- Provincial organizations that represent each of the areas of exceptionality;
- Ontario Teachers Federation:
- School Boards:
- Trustees;
- Parents of students with special education exceptionalities; and
- Students with special education exceptionalities.

The basis for the board's recommendation included the following considerations:

- Bluewater District School Board currently provides special education services and programs to almost one in four of our students:
- Bluewater District School Board is one of the small number of school boards who is
 experiencing a significant reduction in their Special Education Needs Amount for specialized
 support for students with intensive and complex special education needs;
- Bluewater District School Board is experiencing a growing number of students with intensive and complex special education needs at the same time as it is experiencing a steady decline in the overall student enrolment;
- Bluewater District School Board has written previously to the Minister of Education expressing
 concern about the mental health and well-being of students with special education needs and
 their lack of access to a repository or portal of mental health resources that would benefit them
 and their families:
- The growth model of support for students with Autism in Ontario should be applied to all areas of exceptionality;

- Bill 82 was established in 1980 and required the publicly funded school system in Ontario to be responsible for the education of all Ontario students including those with special education needs in their language of instruction (page 8 of George Zegarac's, Assistant Deputy Minister, 2008 address¹);
- The \$20 million infusion in 2006 to the partnership of the Ontario Psychological Association (OPA) and school boards (page 21 of George Zegarac's, Assistant Deputy Minister ,2008 address²) has helped with the backlog of psychoeducational assessments, but there are still significant "wait times" for student assessments;
- Funding from the Special Education Per Pupil Amount and the Special Education Needs Amount (formerly High Needs Amount) are not allocated to specific students nor used on a strict student-by-student basis and represent approximately 93% of the Special Education Grant, (page 25 of George Zegarac's, Assistant Deputy Minister, 2008 address³).
- The current funding structure generates the potential for unequitable distribution of programs
 and resources to students within all areas of exceptionality and across school boards, despite
 the fact that Special education funding has been increasing, while overall provincial enrolment
 has been declining. (page 29 of George Zegarac's, Assistant Deputy Minister, 2008 address⁴);
- There are no updated guidelines or updated definitions for Intellectual (Developmental Disability, Mild Intellectual Disability, Giftedness) or Behavioural Guidelines. (page 18 Ministry of Education Special Education Update June 2015⁵) and only draft Guidelines for Programs and Services for Students Who Are Blind or have Low Vision (K-12). (page 4 Ministry of Education Special Education Update June 2015⁶);
- There is an issue of recruitment and retention of members on Special Education Advisory Committees in various boards across Ontario. (page 3 of the Executive Summary of the PAAC ON SEAC Survey 2014⁷);
- The ministry is currently reviewing Provincial and Demonstration Schools within the framework of Special Education (2015-16)⁸ which has raised concerns about access to very specialized programs that schools boards are not currently able to provide;
- Formal identification and placement decisions through the Identification, Placement and Review Process (IPRC) is on a significant decline and students with special education needs receive supports or accommodations more often through recommendations set out in an Individual Education Plan (IEP) (page 9 A People Report on Special Education 2014⁹); and
- The ministry plans to reconvene the Special Education Funding Working Group to continue to support the transformation of special education funding and other key special education initiatives going forward (Ministry of Education Special Education Update February 2016¹⁰).

- a narrative that links the "special education model" to the *Education For All* and *Learning For All* ministry documents;
- an analysis of the meta data that has been collected by the ministry since the inception of Bill 82
 to discover patterns and insights that would be applicable to the development of a new or
 modified model for special education and appropriate funding for that model; and
- current directions in neuroscience in the review of the current model and development of any future special education model.
