- •Inconsistent feeds to senior (7-8) program (Lackner Woods, Franklin feed both Sunnyside and Stanley Park)
- •Grand River South Community south of Fairway, east of Old Zeller transported out of community (no community school, bus ride length)

Opportunities

- •more permanent space to accommodate current and future students.
- •JK-8 option
- •Consistent feeds for 7-8 program
