2. Background - What is an Accommodation Review?

- a formal public process that ensures a decision taken by a school board regarding the potential future of a school (closure or consolidation) has the full involvement of an informed local community
- a process based on a broad range of criteria regarding the quality of the learning experience for students
- Led by an Accommodation Review Committee (ARC)



2. Background - Accommodation Review Committee

The ARC consists of:

- 2 parents from each school community
- The principal from each school
 - Floradale P.S.
 - Linwood P.S.
 - St. Jacobs P.S.
 - Three Bridges P.S.
- The school area superintendent
 - **■** Diane DeCoene

- Study area municipal representation
 - Township of Wellesley
 - Township of Woolwich
- Up to 2 community representatives
- WRDSB Facilities/Planning Staff



2. Background - Reasons for an Accommodation Review

- Potential exists to house existing and projected students in less schools
- Due to small enrolments, a school(s) are unable to:
 - Provide suitable and equitable range of learning opportunities for students;
 - organize with combined classes of no more than two grades;
- Reorganizing the schools could enhance program and learning opportunities for students
- School and the site are not suitable to provide the programs and accessibility needed to serve the community, and retrofitting and/or enlarging the facility may too expensive
- One or more of the schools is experiencing higher building maintenance expenses than average for the system and/or is in need of major capital improvements;
- The Board has received a formal request from a school community or communities requesting a review of their pupil accommodation facilities




2. Background - Accommodation Review Outcomes

 - School closure or consolidation







3. Issues/Objectives – Draft Objectives

- 1. Ensure equitable student access to a community school by having defined attendance area boundaries that relate geographically to the community it is located in.
- 2. Where possible organize school attendance boundaries to minimize distance to school.
- 3. Address student transitions where changes proposed.
- 4. Have regard for Board policy 3002; Elementary School Size and Configuration, recognizing the challenges of rural areas.




3. Issues/Objectives – Draft Objectives

- 5. Support the efficient use of capital and operating resources through the consideration of facility condition, accessibility, and equitable access to educational amenities.
- 6. Maximize the number of students accommodated in permanent capacity
- 7. Maximize the use of existing capacity within facilities
- 8. Recognize the unique needs of communities served by different schools through the reasonable accommodation of cultural differences.

30 day minimum period between Board announcement of Accommodation Review, and first public consultation

October 18, 2011-?

Public consultation period. Minimum 90 days (not incl.. summer break). Minimum 4 public meetings.





6. Woolwich Wellesley ARC and the WRDSB Rural Education Services Program

Concurrent but separate processes

Accommodation Review

- •About determining the accommodation of existing and future <u>elementary</u> students
- •Number of options are being considered. Some include school closure, some do not.
- •No decisions have been made at this time.

Rural Education Services

- •Strategy is aimed at meeting the educational needs of rural 14+ (secondary) population
- •Strategy not dependant on traditional classroom structure to deliver content
- •Not tied to any specific school of WRDSB facility
- •Decisions related to Rural Education Strategy that impact facilities involved in the Review will occur after the completion of the Review
- •WRDSB committed to working collaboratively with community to identify viable education options for rural JK-12
