Very important boundary change information: Your response is required.

Dear Parent/Guardian of «*First_Name*» «*Last_Name*»:

Please note that on January 14, 2013, the Waterloo Region District School Board voted to close Dickson Public School, effective August 2014 and to change the public elementary school boundaries in the area, ***effective this September 2013.***

Based on your home address of «*Address*», «*City*», we have determined that you reside in “Affected Area E.” There is a map attached to this letter indicating the new boundaries for your area as a result of the Dickson Public School closure. There are a number of parts to this closure and boundary change:

- Effective September 2013, Junior Kindergarten to Grade 6 students residing in “Affected Area E” will be in the Tait Street Public School boundary. Tait Street Public School is located at 184 Tait Street, Cambridge
- Students residing in “Affected Area E” who are attending Dickson Public School on June 27, 2013 are given the option to enrol at either Dickson Public School (SK-5), Highland Public School (SK-5) or Tait Street Public School (SK-6)
 - Transportation will be provided to Tait Street Public School or Highland Public School based on the eligibility criteria set out in *Board Policy 4009 – Student Transportation*
- Grade 4 and Grade 5 students residing in “Affected Area E” who are attending Dickson Public School on June 27, 2013 are given the option to enrol at either Tait Street Public School or St. Andrew’s Public School for Grade 6 during the 2013/14 (this year’s Gr. 5 students) and 2014/15 (this year’s Gr. 4 students) school years
 - Transportation will be provided to either Tait Street Public School or St. Andrew’s Public School based on the eligibility criteria set out in *Board Policy 4009 – Student Transportation*
- Dickson Public School will formally close effective August 31, 2014
- Effective September 2020 all students residing in “Affected Area E” will be required to attend Tait Street Public School for Junior Kindergarten to Grade 6
- Tait Street Public School will offer a Partial French Immersion program beginning with Grade 1 in the 2013/14 school year. Any current SK students interested in enrolling in Grade 1 Partial French Immersion for 2013/14 must register ASAP as space is limited. Please note, any SK student residing in “Affected Area E” will be considered a Tait Street Public School home school

student for the purposes of Grade 1 Partial French Immersion registration. For more information visit: french.wrdsb.ca

- Tait Street Public School will offer the Full Day Kindergarten program beginning in September 2014. For the 2013/14 school year, there will be an all-day, alternate day program.
- An addition of approximately 6 classrooms has been approved for Tait Street Public School. This addition will be completed prior to September 2014.

Please note that the options as described in this letter will only apply to the student's address in "Affected Area E" on June 27, 2013. If a student moves within or outside of the affected area, the options no longer apply. To determine transportation eligibility, please contact Student Transportation Services of Waterloo Region (STSWR) at 519-650-4934 or log onto: www.stswr.ca

There will be no other exceptions granted at this time. To be considered for an exception at a later date, please fill out an out of boundary request form available at your home school. All out of boundary requests will be dealt with through the Superintendent of Education in mid-September.

We are requesting that you fill out, sign and return the attached form by **no later than February 28, 2013**. The information you provide on this form is extremely important to our staffing process that occurs in March. For this reason, please carefully consider the choice you indicate on this form as to the school your student(s) will attend next year as this will be your only opportunity to do so.

We appreciate that this will be a change for your family. Plans will be made to give both you and your children opportunities to visit Tait Street and/or Highland Public Schools to meet staff and members of the school community. It is our hope that these opportunities will help everyone to make this transition a smooth one.

Frequently Asked Questions

Q: I live in the affected area. I have one child currently in Gr. 1 at Dickson P.S. and another that will be entering JK in September 2013. Can my JK student attend Dickson P.S. with their sibling for the 2013/14 school year instead of enrolling at Tait Street P.S.?

A: No, Dickson P.S. will not offer JK classes in the 2013/14 school year. If you want your children to attend the same school, they will both have to attend Tait Street P.S.

Q: I live in the affected area moving to Tait Street P.S., will I have to go into the school to register my child?

A: No. All student records will be transferred automatically from Dickson P.S. to Tait Street P.S. Please make sure to fill out the attached form to indicate which school your child will be attending in 2013/14 so that their records can be dealt with accordingly. If you are registering a student for Kindergarten for September 2013, you will have to do so at Tait Street P.S.

Q: Why are there no exceptions given at this time?

A: Boards are required to meet primary class size caps as set out by the Ministry of Education. Staffing allocations for schools are based on class organizations that have to stay within the primary class size caps. Out of boundary requests may only be accommodated if class organizations can stay within this cap without having to add additional teaching staff to the school. Often this cannot be confirmed until school starts in September (families often move over the summer).

Q: My child has special needs and has great supports at my current school. Will they receive these same supports at their new school?

A: Special Education supports (including resource teachers, child and youth workers and educational assistants) are determined by the overall needs of a school's student population. A student's Individual Education Plan (IEP) identifies what modifications and/or accommodations are needed to support that student. If a student moves to another school anywhere in the Province, their Ontario Student Record (OSR) which includes their IEP, moves with them. It is the IEP that assists schools in determining how best to support that child.

Q: What is going to happen to Dickson Public School once it is closed?

A: If a property or building is no longer needed for school board purposes, it is declared surplus and the board may choose to sell or lease it. Boards must first offer their properties for purchase or lease to public organizations, such as other local school boards, Provincial or Federal agencies, local municipalities, colleges, and universities at fair market value. If no public agency expresses their interest, boards can use the open market to proceed with the sale/lease of the property. All future uses must be consistent with municipal by-laws.
