

Update on New School Construction

- April 25, 2014
 WRDSB received approval to construct a 646 pupil place, JK-8 elementary school located at 314 Sweet Gale Street.
- November 12, 2014
 WRDSB held public engagement event to update public on new school construction.
- Further public engagement session being planned (date TBD)

Boundary Study Process - What is a Boundary Study?

The WRDSB considers a School Boundary Study when considering a change to one or more school attendance areas. There can be a number of reasons for a study:

- Changing the grade structure of an elementary school this would include changing an elementary school from a JK-6 format to a composite school with JK-8;
- Balancing enrolment and facilities one school may have too many students for its capacity and another may have too few;
- After municipalities approve new residential development, the area needs to be assigned to a school where capacity exists;
- Opening of a new school and establishing the new boundary and adjusting boundaries of the existing schools in the area

Boundary Study Process - Role of Working Group

The Working Group will:


- Identify and discuss issues and opportunities of the individual school communities and the broader community
- Set study objectives
- Develop boundary options
- Evaluate boundary options against study objectives
- Act as a liaison between the Working Group and the school communities

Boundary Study Process - Working Group Membership

The Working Group consists of:

- Up to 2 parents from each school
- The principal from each school
- Planning Staff
- The school area superintendent
- Local Municipal representation (City of Waterloo Planning Staff)
- Other WRDSB staff as appropriate

^{**}Scenario development and evaluation may go through multiple iterations as scenarios are evaluated, and new ideas result from the evaluation.

Boundary Study Process - Approvals

- Any changes to the existing school boundaries and grade configurations require the approval of the Board of Trustees. This includes the new Vista Hills area school.
- A recommended Scenario (boundary option) will be presented to Trustees, at a Board meeting, where Trustees will vote on the recommendations
- Boundary changes need to be approved in December of the previous year the changes are to take place (December 2015).


- Boundary required for new Vista Hills area public elementary school
- Enrolment/Capacity concerns at other area schools
- Elementary program model considerations (JK-6, 7-8, JK-8)
- Existing functional deficiencies (ex. Parent pick-up/drop-off, parking, lack of internal spaces, etc.)

Draft Objectives

- **Board Policy 3002 Elementary School Size and Configuration)**

 - JK-6 facilities between 350 and 400 students (approx. 2 classes per grade) JK-8 facilities between 500 and 400 students (approx. 2 classes per grade)
 - Grades 7-8 (approx. 2.5 classes/grade)
- Board Policy 4009 Student Transportation
 - Transportation may be provided for students residing beyond the following distances from their home school
 - JK/SK 800m
 - Gr. 1-8 1600m
- **Administrative Procedure 1000** Partial French Immersion
- Student Transitions
