TRUSTEE PARKING SPOTS

Staff identified several options for a new location for the Trustee parking spots:

• Option 4 - Maintain the current Trustee parking spots and replace 8 of the 11 signs closest to Building 2 to offer public parking before 5:00 p.m. and exclusive Trustee parking after 5:00 p.m., Monday through Friday.

EDUCATION CENTRE RENOVATIONS

This report was provided for information.

As part of addressing the deferred maintenance needs of the Education Centre, several projects have been planned. These projects have been undertaken in an effort to address accessibility, increase Trustees' access to the Chair's Office and related meeting space, better align existing spaces with a modern workflow, provide sufficiently sized space for the Chair to hold meetings in closer proximity to the Trustee Office, the Boardroom and the main entrance to the Education Centre, and create sufficient meeting space within the Education Centre to limit the need and cost associated with using meeting space off site. The project is operational in nature and the budget will be supported through the deferred maintenance plan.

Trustees asked various questions of clarification. Individual trustees raised concerns which included difficulty for people to find the chairperson's office, disconnect from staff and use of financial resources. Other trustees were fine with the project as a whole and felt it would enhance the ability to provide supports within the community and enhance staff well-being.

Director J. Bryant appreciated the trustee feedback and will take take back for consideration.

Staff took note and stated that they continue to focus on working with educational partners such as the Council of Directors of Education (CODE) and Council of Senior Business Officials (COSBO) to provide opinions regarding education funding.
