# Subject: Student Suspension/Expulsion Report December, 2018

### Recommendation

This report is provided for the Waterloo Region District School Board with information regarding monthly and year-to-date suspension/expulsion data.

### **Status**

Comparing year to date from December 2017 and December 2018, elementary suspensions have increased by 24 and secondary suspensions have increased by 128.

Comparing year to date from December 2017 and December 2018, school expulsions have increased by 1 and board expulsions have decreased by 1.

The most recent month's suspension and expulsion data is included below. The data is accurate up to, and including, the date of collection.

### <u>Suspensions</u>

- Total elementary school suspensions in December 2017 118, year to date 510
- Total elementary school suspensions in December 2018 142, year to date 534
- Total secondary school suspensions in December 2017 186, year to date 870
- Total secondary school suspensions in December 2018 220, year to date 998

### **Expulsions**

- Total school expulsions in December 2017 0, Year to Date 0
- Total school expulsions in December 2018 1, Year to Date 1
- Total board expulsions in December 2017 2, Year to Date 9
