Subject: Student Suspension/Expulsion Report March, 2020

Recommendation

This report is provided for the Waterloo Region District School Board with information regarding monthly and year-to-date suspension/expulsion data.

Status

Comparing year to date from March 2019 and March 2020, elementary suspensions have increased by 67 and secondary suspensions have increased by 44^{*}.

Comparing year to date from March 2019 and March 2020 school expulsions have decreased by 1 and board expulsions have decreased by 4*.

The most recent month's suspension and expulsion data is included below. The data is accurate up to, and including, the date of collection.

Suspensions

- Total elementary school suspensions in March 2019 162, year to date 965
- Total elementary school suspensions in March 2020 111, year to date 1032*
- Total secondary school suspensions in March 2019 170, year to date 1426
- Total secondary school suspensions in March 2020 114, year to date 1470*

Expulsions

- Total school expulsions in March 2019 1, Year to Date 3
- Total school expulsions in March 2020 0, Year to Date 2*
- Total board expulsions in March 2019 4, Year to Date 18
- Total board expulsions in March 2020 2, Year to Date 14*

Violent Incidents

The term violent incident is defined as the occurrence of any of the following or the occurrence of a combination of any of the following; possessing a weapon, including possessing a firearm, physical assault causing bodily harm requiring medical attention, sexual assault, robbery, using a weapon to cause or to threaten bodily harm to another person, extortion, hate and/or bias-motivated occurrences.

- Total elementary/secondary violent incidents in March 2019 7, year to date 31
- Total elementary/secondary violent incidents in March 2020 5, year to date 28*

*No data was recorded during the COVID-19 closure period. Year over year comparisons are not valid.

All nine applicants were confirmed to meet the criteria and were selected to receive the 2019-20 Linda Fabi Bursary.

Background

The Linda Fabi Bursary was established by the Board of Trustees in celebration and recognition of the many contributions and achievements of Linda Fabi during her tenure as Director of Education for the Waterloo Region District School Board.

The total amount of the Bursary this year is \$2,025, which is to be presented to students of the Waterloo Region District School Board. Depending on the number of applicants, this award can be divided so that a number of eligible applicants can be recognized. This year each student will receive \$225.

Financial implications

An amount of \$2,025 will be charged to the Trustee expense budget. This is the sixth year the award has been issued.
