# **REVIEW OF BOARD POLICY 1010 - ACCESSIBILITY FOR ONTARIANS WITH DISABILITIES**

Trustees asked about the process used to ensure the policy is being followed during the hiring process. Coordinating Superintendent M. Weinert agreed that staff could perform a spot-check to verify if the policy is being adhered to and report back to trustees with the findings.

#### **REPORTS**

#### 2020-21 INTERIM FINANCIAL REPORT AND FORECAST

The report was provided for information.

Coordinating Superintendent M. Gerard and N. Landry, Controller - Financial Services shared the report which includes the key budget risks for 2020-2021 and the first quarter financial reports. The report noted the limited ability of staff to significantly alter the forecast of the year-end financial position based on three months of operations, particularly in a year filled with uncertainty regarding the ongoing impact of COVID-19. Consistent with the approved budget for 2020-21, staff expects the WRDSB to finish the year in a deficit position.

Trustees asked questions regarding the deficit, purchasing commodities and enrolment.

## MAJOR CAPITAL PROJECTS QUARTERLY UPDATE

The report was provided for information.

Coordinating Superintendent M. Gerard shared the report which included current capital projects with budgets greater than \$2.5M. The report provided the status of each project relative to the schedule, budget and scope. Significant milestones, along with basic project statistics, were also presented. All projects are proceeding as planned through the design and construction stages with the exception of the two childcare additions at Saginaw Public School and Lackner Woods Public School. Business Services is still awaiting a response of "Approval to Proceed", for both projects, which were submitted to the Ministry for additional funding prior to tendering these projects.

Trustees asked questions regarding the timing of the two childcare additions.

## **QUESTION PERIOD**

Trustee M. Ramsay asked how Administrators are supervising their staff and ensuring educators are being accountable in a virtual environment. Director J. Bryant confirmed that Administrators continue to meet with and supervise staff both virtually and in person. Both Learning Support Services and Information Technology Services continue to support and offer resources to assist Administrators in their duties. Expectations for Administrators have not changed. Associate Director L. Read shared that the Administrators assigned to the Distance Learning Program are working closely with educators to develop individualized plans to assist students in need of re-engagement.

As a follow up, Trustee M. Ramsay asked how a parent could share their concerns with the administrator and if classes are recorded. Associate Director L. Read shared that parents should follow the normal communication channels. The list of Distance Learning Administrators is available online or parents can also reach out to their home school Administrator to direct them accordingly. It was also noted that educators are not recording live classes with students present, but that a teacher may pre-record a lesson to share with their class.

Trustee S. Piatkowski expressed concerns for staff working with students who are unable to wear masks and asked if we would request vaccine prioritization for these staff members. Coordinating Superintendent M. Weinert shared that we can ask Public Health to bring forward a request to the province and that the Minister of Education also intends to.
