## **REPORTS**

## **COVID-19 PANDEMIC - VERBAL UPDATE**

Director J. Bryant introduced the update and the topics to be covered. Associate Director L. Read updated trustees on the regularly scheduled vaccines for students, and that at this time, we have not been informed of any requirement for students to receive both COVID-19 vaccinations in order to attend school. Superintendent B. Lemon updated trustees on the vaccination rollout and vaccination sites. He noted that the use of volunteers in schools next year will be determined by the Ministry of Education's reopening guidelines. He also shared that staff worked closely with local Public Health to determine the health and safety protocols for year-end activities and connections.

Trustees asked questions regarding advocating for volunteers and receiving the reopening guidelines from the Ministry as soon as possible, fall commencement and year-end activities.

## 2020-2030 LONG-TERM ACCOMMODATION PLAN

The final version of the Waterloo Region District School Board (WRDSB) 2020-2030 Long-Term Accommodation Plan (LTAP) updates the 2017 LTAP. It identifies short-term (one-to-five years) and medium-term (six-to-ten years) accommodation recommendations. The recommendations highlight priority areas for classroom additions, boundary studies, partnership opportunities and pupil accommodation reviews.

#### **ONTARIO PUBLIC SCHOOL BOARDS' ASSOCIATION (OPSBA) UPDATE**

Trustee L. Tremble provided an update from the Annual General Meeting and Board of Directors' Meeting. The OPSBA Annual Report is available on the OPSBA website. She shared that OPSBA will be watching for further updates on the Ministry of Education's online learning proposal. OPSBA has started its Above and Beyond public awareness campaign and work continues on Project Compass.

Trustees were encouraged to read the OPSBA discussion paper in preparation for next Monday's discussion.

## AD HOC SUSPENSION REVIEW COMMITTEE 2020-21

Trustee S. Piatkowski provided background on the work of the Suspension Review Committee and the delays it faced due to the pandemic and labour sanctions.

Superintendent B. Lemon provided a presentation which reviewed the challenging times, learning from the suspension data, The Keeping Students in Schools pilot program, restorative practices and the resulting recommendations.

Trustees asked questions regarding expanding the Keeping Students in Schools program.

In addition, in the school year following the implementation of the new Student Information System, WRDSB staff will develop a strategy for ongoing monitoring and analysis of Suspension & Expulsion data at the school and system level; and with the acceptance of the recommendation, this ad hoc committee will be disbanded as its mandate is complete.

#### AD HOC SCHOOL RESOURCE OFFICER REVIEW COMMITTEE FINAL REPORT

Trustee K. Meissner provided an opening statement regarding the final report from the Ad Hoc School Resource Officer Review Committee. She referenced the work of the committee, including the decision to not consult WRDSB students so as to not cause additional harm or trauma. The committee used data gathered from other sources such as research papers and other school board reviews. The committee believed that the results of a survey would not show anything new or different compared to that of other school boards.

Trustees discussed the recommendation including the decision to not consult with students.

4. That the Waterloo Region District School Board reviews the local School-Police Protocol through an equity, anti-racist, and anti-oppressive lens.

5. That the Waterloo Region District School Board explores restorative justice strategies and practices when addressing student discipline issues.

6. That the Waterloo Region District School Board write a letter to the Region of Waterloo, requesting that the funds previously used to deliver the School Resource Officer Program within the Waterloo Region District School Board be reallocated to community-based services for youth.

## AD HOC SCHOOL NAMING REVIEW COMMITTEE UPDATE

Per the mandate established in the Terms of Reference, the Ad Hoc School Naming Review Committee (Committee) reviewed Policy 4020 - Naming and Renaming of Board Facilities using an anti-racist, decolonial and trauma-informed lens. Committee members independently used the Policy Review Guide developed by the Indigenous, Equity and Human Rights Department to review the existing policy. The revised Policy 4020 redresses the omissions in the existing policy and reflects the WRDSB's commitment to Indigenous education, equity and inclusion, human rights and the importance of Reconciliation.

Trustee K. Woodcock provided an update on the work of the Committee to date and information on upcoming work. Superintendent P. Rubenschuh shared that engaging the community was a priority for the committee.

Trustees made comments in favour of the motion. It was asked if the committee had considered assigning a temporary name for Sir John A. MacDonald Secondary School while a review is undertaken.

## **QUESTION PERIOD**

Student Trustee R. McDonald began to make a statement regarding the Ad Hoc School Resource Officer Review Committee Final Report. Chairperson J. Given discussion on the agenda item had been completed, Chairperson J. Weston ruled against the Point of Order and directed Student Trustee R. McDonald to ask a question.

Student Trustee R. McDonald asked if next year the Board would consider further consultation regarding police involvement in schools. Superintendent P. Rubenschuh shared that there is a provincial police protocol in place that will provide direction for our relationship with the Waterloo Region Police Service. The motion approved today includes plans regarding community support.

Trustee M. Ramsay asked when the Board would have a renewed focus on student achievement for all students rather than have a revolution every day. Director J. Bryant confirmed that staff continue to focus on student achievement and well-being for all students, even through the pandemic.

Trustee C. Watson asked when and how the School Resource Officer program ending will be communicated to students, families and the community. Director J. Bryant reminded trustees that the decision will have to be ratified at the upcoming Board Meeting, after which a communication plan would be developed.
