#### FRENCH IMMERSION REVIEW COMMITTEE UPDATE

The French Immersion Review Committee has begun Phase 3 of the review. A document articulating the vision, goals and principles for French Language Programming in the WRDSB is in the final stages of revision. The final version will be shared with the French Immersion Review Committee when they meet in the fall. The Committee will continue addressing the main areas needing improvement as identified in the Malatest Report. Recommendations from the Committee will be presented to the Board early in 2022. Staff confirmed that trustees can anticipate implementation for September 2023.

Director J. Bryant introduced the presentation and the Guiding Principles developed to direct efforts toward the return to school and work. Associate Director L. Read reviewed the planning for in-person learning for the 2021-2022 school year. Superintendent R. DeBoer shared information regarding the Secondary Remote Learning Program. Superintendent

E. Giannopoulos shared information regarding the Elementary Remote Learning Program. Superintendent B. Lemon provided information regarding vaccination clinics in schools. Director J. Bryant closed the presentation with expressions of gratitude.

Trustees asked questions regarding staff vaccinations and secondary assessments and cohorts.

#### TRUSTEE SELF-EVALUATION

Trustees were invited to complete a self-evaluation survey as an opportunity to share their experiences and communicate their needs to each other. This survey was voluntary and respondents could skip any question they did not want to answer. All eleven WRDSB Trustees participated in the Self-evaluation.

Trustees discussed the decision to not have student trustees complete this survey as they have different experiences. Student trustees were given a different opportunity to provide feedback.

Trustee C. Millar shared the next steps for the committee including recommendations for professional development or opportunities. Additional suggestions for improvement included the

importance of attendance of all trustees at professional development opportunities to improve understanding of complex issues.
