Subject: Reported Student Aggression Quarterly Data

Q4 - 2020-2021

Recommendation:

This report is provided for the Waterloo Region District School Board with information regarding reported incidences of student aggression for the quarter (**April 16**, **2021-June 30**, **2021**).

Status:

Due to the COVID-19 pandemic, unplanned disruption continued for the remainder of the 2020-2021 school year (pivoting from In-Person to Remote and vice versa) impacting the continuity in delivery for students within our system. These impacts have resulted in a significant reduction to the student aggression numbers. Due to the highly ambiguous nature of this pandemic, it is difficult to forecast future student aggression levels.

Having said that, we continued to be proactive in utilizing our BMS team to support staff and administration in the following ways:

- Secured temporary funding to continue temporary support through two (2) BMS Liaisons for the 2021-2022 school year;
- Responded to student specific referrals addressing supports for safety plans, review of critical incidents, and classroom observations and audits;
- Provided BMS support to specific site requests (i.e. practice a containment, student specific interventions etc.);
- Supported the growing system needs in BMS by training new trainers (23 new trainers trained during this quarter);
- Assisted in facilitating the transition of students returning to In-Person learning;
- Directly supported transition planning to ensure staff feel supported and that we are setting both students and staff up for success;
- Organized caseloads, discussions and preparation for supporting students returning to In Person learning in September of 2021;
- Proactively identified schools and students that may require direct support from BMS in September of 2021;
- Provided on-going training for multiple employee groups within the Board; and

 Successfully completed the training required to meet the entire BMS 2020-2021 System training plan through multiple modes. The BMS team and BMS trainers worked diligently to navigate through the Covid-19 precautions and restrictions.

Student Aggression incidents are recorded under four (4) categories in order of severity from least severe to most severe:

Hazard: The worker is reporting a hazard, the worker sustained no injury during the incident or it was a near miss. The Board and Unions actively encourage employees to report workplace hazards in order to act proactively to prevent more serious incidents.

First aid: Applying minor first aid measures like cleaning minor cuts, scrapes or scratches; applying a band aid, cold compress or ice pack. First Aid is provided at the workplace.

Health care (or medical aid): Worker sustained an injury requiring medical aid from an external health care practitioner (i.e. a doctor, nurse, chiropractor or physiotherapist); services provided at a hospital and/or health facility and/or require prescription drugs. This is required to be reported to the Workers Safety and Insurance Board (WSIB).

Lost Time: The worker sustains injury that requires time away from work after the day of incident and was unable to work. This is required to be reported to the Workers Safety and Insurance Board (WSIB).

Previous Year Quarterly Report Comparison:

There were no student aggression incidents for the period of April 16, 2020 – June 28, 2020 due to the COVID-19 system closure.





Dear Minister Lecce and Minister Elliot:

The Trustees of the Halton District School Board unanimously adopted the following motion at the most recent regular meeting of the Board of Trustees on September 1, 2021:

"Whereas COVID-19 vaccines have been approved by Health Canada to be safe and effective for students born in 2009 or earlier;

And whereas the purpose of the <u>Immunization of School Pupils Act</u> is "to increase the protection of the health of children against the diseases that are designated diseases".

And whereas the Immunization of School Pupils Act mandates that students be immunized for "designated diseases": diphtheria, measles, mumps, poliomyelitis, rubella, and tetanus, unless a specific exemption is sought through the act;

Be it resolved that the Chair write a letter to the Minister of Education and Minister of Health to ask that the Immunization of School Pupils Act be amended to include COVID-19 as a "designated disease".

Currently, there is no mandate for eligible students to be vaccinated against COVID-19. The addition of COVID-19 as a "designated disease" within the Immunization of School Pupils Act will serve important purposes:

- First, it may inspire an increased uptake of the vaccine which will provide protection for those who are too young or medically unable to be vaccinated in school communities. This will result in a safer learning environment for students, staff and their families.
- Second, the Act provides a mechanism for exemptions that includes parental education on vaccination. This element is missing right now in consideration of COVID-19 vaccination for students.

We are adding our voices to the Ontario Public School Board Association, People for Education, and a number of boards who have made this same request.

On behalf of the Trustees of the Halton District School Board, I would like to thank you in advance for your consideration of this request to further improve the safety of the learning environments in Halton and across Ontario.

At its meeting on August 30, 2021, the Board of Trustees for the Waterloo Region District School Board (WRDSB) agreed to write to you to strongly urge the Ministry of Education (Ministry) to provide and fund an enhanced level of mask, equivalent or similar to KN95 or N95 respirators, for staff and students. In addition, the WRDSB requests the Ministry support school boards with the costs associated with the proper fitting of these masks.

Given the prevalence of the COVID-19 Delta variant and recent research proving the COVID-19 virus is aerosolized, with higher transmission rates and the potential to cause more serious illness, this an urgent concern.

KN95 and N95 respirators provide greater protection against exposure to respiratory viruses compared to ASTM rated medical face masks. The use of KN95 and N95 respirators will provide protection for those who are too young or medically unable to be vaccinated in school communities and will result in a safer learning environment for all students, staff and their families.

Minister Lecce, we ask for your serious consideration of this request, as it will protect the health and safety of all students, staff and their families in the WRDSB and throughout Ontario, thus ensuring students continue to have the opportunity to learn in-person.

On behalf of the Board of Trustees for the Waterloo Region District School Board (WRDSB), I am writing to you to express our support for the letter you received from the Halton District School Board dated June 18, 2021, in which they asked:

"That the Provincial Government and more importantly the Ministry of Education be accountable to the TRC Calls to Action on Education that were passed in June 2015, by reviewing and revising the Indigenous history curriculum materials, which were developed in 2018 but never released by the current government, so they can be introduced in schools this Fall."

In May, the unearthing of the remains of 215 Indigenous children on the grounds of the Kamloops Indian Residential School in British Columbia was a sad reminder of the lack of knowledge of Indigenous history that so many Canadians have. In the absence of provincial direction on the Calls to Action 62-65, the WRDSB like other boards, has begun to embed First Nations, Inuit, and Metis histories into programming. However, without leadership from the province this action will result in inconsistencies in programming.

Minister Lecce, we ask you to recognize the urgency of introducing Indigenous history curriculum and expedite this process to release updated curriculum to schools across the province immediately.

On behalf of the Board of Trustees for the Waterloo Region District School Board (WRDSB), I am writing to request the Ministry of Education (Ministry) review the benchmark funding formula adjustment to ensure it accounts for statutory increases in Employment Insurance (EI), Canada Pension Plan (CPP) and pension contributions and other similar increases.

The current benchmark funding formula increases do not consistently cover the amount of increases that occur on an annual basis with these benefit expenses. These unfunded expenses are absorbed in existing budgets that would otherwise have been directed towards student achievement and well-being initiatives.

We ask that the Ministry review these discrepancies in the benchmark funding formula and seriously consider adjusting it to reflect the actual statutory increases in these benefits.
