ELECTION OF BOARD CHAIRPERSON/VICE-CHAIRPERSON

APPOINT SCRUTINEERS

OUTGOING CHAIRPERSON'S REMARKS

Outgoing Chairperson J. Weston presented the following remarks:

I would like to start by thanking everyone who supported me over this past year as Chairperson. It has been a year like no other and I could not have done it without you.

When I took on the role of Chair, I honestly hoped that the pandemic would be mostly behind us by midyear and we would be back to normal schooling and meetings by the fall. Unfortunately, the pandemic continues to dominate our lives; though with everyone over age five now eligible for vaccinations, I am hopeful for 2022. But, whatever happens in 2022, we must continue to challenge ourselves on how we can do better for each and every one of our students.

This Board of Trustees started work in 2021 with three important ad hoc committees that reviewed suspensions, the SRO program and school names. The committees recommended, and the Board of Trustees agreed, that changes were required to improve our schools and make these spaces safer for students. Some of these discussions were difficult, but I am very proud of the decisions this Board has made to ensure each and every student can learn in a supportive and safe environment.

I am also proud of the advocacy work this Board has done. We advocated for stop-arm cameras, that mandatory Black history be added to the curriculum and for additional support from the Ministry to help prevent the spread of COVID.

This year, we said goodbye to Director John Bryant as he retired and hired Director jeewan chanicka as our new Director of Education. It has been my absolute pleasure to get to know and work closely with Director chanicka. I know our students, staff and families are in good hands as he focuses on building relationships and preparing our students for the 22nd century.

I want to take this opportunity to recognize the incredible work everyone across the system is doing - the senior team, teachers, support staff, bus drivers, crossing guards and staff at the Education Center. Thank you all for continuing to be creative and finding ways to engage and support students, while keeping them safe, in another challenging year. I recognize the stress and sacrifice that is behind all the work that you are doing. I wish you all a restful break later this month. Again, thank you all.

I also want to thank Chair Piatkowski for his support as Vice-Chair and Trustee Herring as Past Chair. Your support and advice have been invaluable.

It has been my honour to serve as Chairperson of the WRDSB. I have every confidence in Chair Piatkowski and Vice Chair Woodcock to lead our board through 2022 and the challenges and accomplishments that lay ahead. I look forward to supporting them as we, together, support the students, staff and families in our Board.
