## **QUESTION PERIOD**

Trustee C. Watson asked if Central Public School Council members were told not to oppose or discuss opposition to the Consumption and Treatment Site (CTS) site at 150 Main St, Cambridge at parent council meetings. Superintendent E. Giannopoulos shared the role of school council and that staff would not prohibit families from expressing views. Staff are working to support families to learn more about the CTS. In conversations with the Central Public School Council last week, members had a willingness to learn more about existing CTS in Kitchener and Guelph. Trustee C. Watson asked if the School Council can voice opposition to CTS at the school council meeting. Director j. chancika shared that staff does not take a position but rather facilitates answering parent questions. This has been on school council agendas and discussed.

Trustee M. Ramsay asked if school councils are discouraged from sharing their thoughts on CTS. Associate Director L. Read shared that school councils have not been discouraged from voicing concerns or having a discussion. School council is a vehicle for sharing concerns and that Superintendent E. Giannopoulos is looking to bring in individuals to assist in answering those questions in consultation with the school council. Trustee M. Ramsay asked if school councils can share their thoughts through the school. Director j. chanicka reinforced that school councils is a place for issues and concerns to be raised and the role of staff in the matter is to try and provide comprehensive information when questions are asked.

# **FUTURE AGENDA ITEMS**

Trustee C. Watson served the following Notice of Motion with support from Trustee M. Ramsay:

Whereas Central Public School Council parents have been told that they cannot oppose or speak in opposition to the Consumption Treatment Site of 150 Main at School Council Meetings,

Whereas parents have been told to organize their opposition apart from Central School Council Meetings and Central Public-School Property,

Whereas the Education Act, Reg. 612/00, section 20, Advisory Authority of School Councils and the WRDSB School Council Handbook links, state that a School council can make recommendations on any matter to the principal and the board.

Therefore, be it resolved that the Waterloo Region District School Board allow the parents of Central Public School to express their opinions, supportive or in opposition to the CTS site of 150 Main at the School Council Meetings, which are sanctioned by the Education Act, and allow the School Council to provide recommendations to the principal and the board of Trustees regarding the CTS site of 150 Main.

And that this motion be presented to the board no later than February 2022.

Trustee K. Woodcock served the following Notice of Motion with support from Trustees K. Meissner, J. Herring and J. Weston:

That the Board direct the chair to send a letter to the Minister advocating for a pause of EQAO testing for this year. I would also propose that the Chair ask a question about pausing EQAO at the next Chairs/Minister teleconference.
