#### WRDSB Special Education Update – Scott Miller

- Welcome to Christine MacDonald now a member of SEAC representing the Learning Disabilities Association
- Ministry of Education Update
  - All Students returned to in-person learning on February 8, 2021
  - Mandatory masking for students Grade 1 to 12 (WRDSB already compliant, current practices are Kindergarten to Grade 12)
  - Additional safety requirements imposed by the Ministry for return to in person learning (most have already been implemented by the WRDSB)
  - Received confirmation from the Ministry that there will be grant funding for this summer to support programming and student well-being. In the WRDSB this will include mental health support through WRDSB Psychologists and Social Workers, Literacy and Numeracy Programs and transition planning.
- In Person and Distance Learning Update
  - Survey for parents with Elementary aged children was closed on January 29th to request a change in their child/children's learning mode. Reorganization plans are currently being completed and the switch to in-person learning will be on March 4th and the switch to distance learning will be on March 8th.
  - Currently working on a revised 5 year plan accessibility plan as per the AODA
     Legislation. When the initial draft is completed, it will be brought to SEAC for
     review and feedback. The timeframe to bring this draft will be in March or April
     of this year.
- Discussion: What has this year's school experience been like for students/families/caregivers in your association?
  - Common feedback received from all associations:
    - Parents missing the parent to parent connection
    - Social aspect of school is being missed by students
    - There is a lot of demands on parents in having to support their child/children at home when external service providers are not always available or able to provide respite care

- Concern over non technical SEA Equipment being housed at schools and not being used
- Accommodations aren't being met. Students with exceptionalities have mixed feelings about how the quadmester is working
