



## IS-19-L Student Media Release Consent Form

The following uses of your/your child's personal information require specific written consent. Please read the following information, check the appropriate boxes, and return the form to the classroom/homeroom teacher as soon as possible.

### Part 1 – WRDSB Specific

I understand that the Waterloo Region District School Board (WRDSB) may record, film or photograph my/my child's name, image, student work, and performance. This may include school names and grades in relation to my/my child's involvement/accomplishment in an event, activity, or sport (to be referred to as "Works"). Works may be collected as a result of school or board events, athletic activities and promotional campaigns, and may be displayed, published or distributed for the purpose of posting on the WRDSB website, school websites and WRDSB social media sites. Please note that Works may be used beyond the current school year.

### Part 2 – Media Specific

I understand that external media organizations may attend school events, including but not limited to sporting events, student performances, and science fairs. As a result, my/my child's Works (name, image, grade, student work, and performance) may be photographed, filmed or audio-taped for the purpose of being published and/or broadcast on media websites, on television or radio.
