- Presentation
 - Updated to remove the word "Code" and replaced it with Student Dress
 "Policy"
 - Students have received a greater voice regarding the policy by providing feedback
 - The Policy is going to the board on June 20th, 2022

WRDSB Special Education & Student Well-Being Report – Scott Miller

- Right to Read Update
 - We will be providing training for our staff
 - The Right to Read Report is a call to action and has 157 recommendations
 - Focuses on the "Big 5" which are the essential reading components that include phonics, phonological awareness, fluency, vocabulary and comprehension

- Considering how we use our Speech Language Pathologists to support students
- We are building "sound walls" instead of "word walls"
- Some schools have a greater need than others
- We have 38 teachers allocated as Reading Resource Teachers who will be embedded in schools will assist with the implementation of the Empower Program in grade 2
- The Resource Teachers will be able to provide in classroom support, instruction and small groups work
- There are central staff including program leads, equity/special education/program consultants that are registered for the Introduction to Structured Literacy Instruction Course being provided by International Dyslexia Association Ontario. ACE consultants are included in the training and will support students in the ACE classrooms.
- The Board continues to look at next year. Looking at a universal screener which allows students to engage. We are able to do further assessments to assist at-risk students. We can provide interventions to allow students to stay with their peers.
- SEAC Feedback Equity and Sovereignty Leadership Competencies
 - Document would be supported by training and engagement
 - We provide opportunities for system leaders to acquire these competencies so when they come to the interview, we expect them to be able to speak to that
 - Training or professional development associated will be part of the implementation
 - These competencies will be used as a guide to elevate awareness and support system leaders in their capacity building,
 Superintendents, principles, vice principals and managers
- Planning for 2022-2023 and Reflecting on 2021-2022
 - New Strategic Plan is in process

- Our North Star "To ensure that identity and social location no longer predict outcomes, TOGETHER we will transform our systems, structures, physical environments and practices to center the needs, lived experiences, abilities, and stories for students and staff to ensure success for ALL"
- Continue to use this to help center the work that we all do
- This is something to celebrate as its the feedback from all groups
- It's a reflection on the work that we have had the last couple of years and how we move forward

 - Reviewed letters and will send a letter in support for both Boards regarding the nursing shortage

 - SIP is a small piece of our funding. We get most of our money per pupil funding and some of that money goes towards special education support.
 - Suggested to have a further discussion in September regarding the breakdown of funding the board receives so we can understand the letter better and provide a response.

 - Messages came from the Ministry in the new year which provided various questions. A lot of the implementation has been put on hold due to the consultation and feedback they have received. The Ministry of Health and Education are continuing to review and this is on pause for now. There will be no changes to the current practice for the next school year.
 - Reviewed letters and no further action to be taken
- SEAC Handbook Draft Copy (Group Discussion)
 - The current handbook is on the website and is meant to provide guidance to SEAC members
