WRDSB Special Education & Student Well-Being Report – Scott Miller

- Guide to Remote Learning for Students with Special Education Needs
 - Educator Tip Sheet, Parent Tip Sheet, Student Tip Sheet
 - We received these resources from the Ministry to share with staff and SEAC
 - Provides specific recommendations for best practices for educators,
 parents and students
 - Currently we have roughly 3000 elementary students and 1000 secondary students that are participating in remote learning
- Review Individual Education Plan Resources
 - Collaborating with Students and Families Consultation for IEP
 Development
 - 2. <u>Identifying Student Strengths and Needs An Asset Based Approach to IEP Development</u>
 - 3. <u>Documenting Through Non-Clinical Assessments an Asset Based</u>
 <u>Approach to IEP Development</u>
 - Tier 1 Interventions Differentiated Instruction, Universal Design for Learning and Accommodations - An Asset Based Approach to IEP Development
 - Currently staff is working on a new resource focussed on an Asset Based
 Approach to IEP Development
 - These documents have been shared with a number of groups and stakeholders for recommendations. We will continue to review with SEAC to provide opportunities for feedback
 - The Special Education Department will center their attention to the ongoing work with IEP development and supports for our students
- Staffing Updates
 - Interviews have taken place for the temporary Mental Health Lead position. Currently we are finalizing the hiring of a candidate and an announcement will be made once the person has been hired

PRO Grant

- Parent Involvement Committee (PIC) information on the WRDSB website provides an overview of this committee
- Parents Reaching Out Grants (PRO) information on the Ministry website.
- The PRO grant evaluation committee is looking for two SEAC members to join the committee to review and approve applications received from schools and PIC
- The PRO Grant Evaluation Committee meets 1-2 times (depending on the number of applications received) between February 1 and February 10 for approximately 2.5 hours to evaluate the applications received from schools and PIC. A quick follow-up meeting, during this time frame, may be required to finalize the decisions regarding successful applications
- The PRO Evaluation Committee includes representation from the following areas: Parent Involvement Committee (2), Special Education Advisory Committee (2), the Equity and Inclusion Advisory Group (2) and a Trustee

- Angela Sider provided further clarification on the work from previous years when she has sat on this committee and can assist if there are no other volunteers

• Jordan's Principle - Stephen McCrae

- Jordan's Principle is a child-first principle that aims to eliminate service inequities and delays for Indigenous Children and Youth. Jordan's Principle states that any public service ordinarily available to all other children must be made available to Indigenous Children and Youth without delay or denial
- We have seen an increase in families beginning to use this resource
- There is an application process which we work with school administrators and the Human Resources and Equity Department

- This funding can be used to hire supports for Indigenous Children and Youth
- We are learning how to best access the use of Jordan's Principle by connecting with other school boards as this is new to process to many administrators and school board

- 1. Roberta Thompson, Waterloo Wellington Down Syndrome Society

- 2. Kathy Waybright, Ontario Federation of Cerebral Palsy
 - Ontario Health, in partnership with the <u>Provincial Council for Maternal and Child Health</u> has drafted a quality standard for care for young people who are transitioning from youth to adult health care services. We are hoping for your help in collecting feedback on this draft.
 - This quality standard outlines what quality care looks like for young people aged 15 to 24 years who are transitioning from youth to adult health care services based on the best evidence and with input from clinicians and people with lived experience.
 - Quality standards are designed to improve care in Ontario and target priority areas in need of improvement. They will help:
 - Patients, residents, families and caregivers know what to discuss about their care with their health care professionals;
 - Health care professionals offer the highest-quality care based on the best available evidence;
 - Health care organizations and professionals measure, reflect on their practice and improve the quality of their care; and
 - Health system planners create the environment for healthcare professionals and organizations to deliver quality care.

- A <u>Memo</u> was sent to school boards regarding health services at school, and the planned review of <u>Policy/Memorandum 81</u>, Provision of Health Care services in School Settings.
 - This PPM was developed in 1984 and together with the <u>Interministerial Guidelines for the Provision of Speech and</u> <u>Language Services</u> (1988) have been key documents in the provision of nursing and rehabilitation services at school for many years.
