WRDSB Special Education & Student Well-Being Report – Scott Miller

- Meetings are still being held virtually but there will be the opportunity in the future to have a hybrid model
- Due to the cyber attack, transportation for some of our special education students didn't start until September 12th. We did advocate for our students to get transportation and appreciate all the hard work Student Transportation Services of Waterloo Region (STSWR) has done to set-up the transportation.
- Round table introductions from all members
- WRDSB Strategic Plan
 - Trustees, parents, students, staff and community voice provided
 feedback through a survey to assist with input for the new strategic plan
 - There will be continued work on the plan as it evolves
 - Director of Education jeewan chanicka Response to Strategic Plan

- Ministry of Education Update
 - We will receive additional funding for autism entry to school program
 - Our Board is following some of the recommendations of the Right to Read Report and the Ministry guide to early literacy to implement a number of supports for our students.

- The consultants in Special Education, Curriculum and Indigenious, Equity
 & Human Rights are taking courses on structured literacy
- 38 Reading Resource Teachers are engaged in learning to do high level interventions to support students in classrooms
- Additional licenses have been added to schools for the Lexia Reading Intervention Program
- There has been a lot of work around functional literacy in the ACE Program and will continue this work with the students

Chair Report

- Upper Canada DSB Letter to Ministry Re: PPM 81
 - Reviewed letter and no action required
- Reflections from the 2021-2022 School Year
 - Minister's Advisory Council on Special Education (MACSE)
 - Requested feedback from SEAC members to be added to the <u>Communication: Collaborating with the Community form</u> due by October 4th, 2022. L. Gil to send to all members for their input.
- Goals for the 2022-2023 School Year
 - Biggest challenges have been hiring Paraprofessionals Educational Assistants and Child Youth Workers as we try to fill in the gaps
- Discussion Secondary ACE Classes
 - Concerns brought forward by Jane Martin, representative of Ontario
 Federation of Cerebral Palsy regarding the lack of EAs and fail to fills in
 high schools
 - The students in the classes are ACE Medically Fragile, ACE Autism and ACE Developmentally Challenged with multiple exceptionalities
 - Currently a suggested rotating EA schedule is being proposed
 - There is concern over the EAs not knowing the student and being able to support the students as they have high needs. Safety has to be first and the EA needs a special skill set to support the students.

- Recommends keeping 2 permanent EAs in the class and rotate the 3rd
- Concern that parents haven't been consulted about this new routine
- Masking is also a safety concern as the students can't wear masks and the staff is not required to wear a mask
- Parents feel disconnected and isolated from other parents as the students are from all over the region. Would like to look into connecting with the families after school which would provide the opportunity to support each other. Would like to see what other SEACs and schools are doing to have families connect and support each other outside of school
- J. Albrecht and S. McCrae will follow-up with J. Martin to investigate further with the high school
