#### **Special Education Update**

Welcome Back - Introductions were made. S. Miller, Superintendent, Student Achievement & Well-Being, provided a brief employment history of his new administrative assistant, Leonilda Gil who will be at the meeting in October.

Special Needs Strategy Overview and Collaboration - Melanie Gravel, WRDSB Chief Speech and Language Pathologist, joined the meeting tonight to offer insight on this subject. Two and a half years ago the Special Needs Strategy was started that included stakeholders from school boards and community association to provide suggestions/ideas for a change to service delivery in our region. The Friday before the September long weekend, the board received news from the Deputy Ministers of Child and Youth Services, Health and Education that all plans for the Special Needs Strategy were to be halted. S. Miller provided the following highlights;

CCAC has been transitioned to LHIN (Local Health Integrated Network) - This means that any services previously supplied by CCAC (OT, PT and Speech therapy) will be transitioned to Care Treatment Centres as of April 1, 2018 (in Waterloo Region, that will be KidsAbility). The school board will continue with their current speech and language model.

As a result of this announcement nothing changes in regards to the delivery of services provided in Waterloo Region.

The intent of the Special Needs Strategy was to move towards integrated rehabilitation. In the near future the government will bring a provincial expert advisory committee to work towards a provincial model that can be used in all communities and school boards.

Priority Planning for SEAC Vision and Guiding Principle Document - The document continues to be reviewed. Groups discussed focused on what are priorities/goals for actionable items and were asked to list top 2 for each Guiding Principle. The information will be collated and provided at a future meeting.

Ministry K-12 Special Education Document: A Revised Policy and Resource Guide (http://www.edu.gov.on.ca/eng/document/policy/os/onschools\_2017e.pdf).

The document thoroughly explains all aspects of Special Education in Ontario.

WRDSB Special Education Plan - A copy of the plan is on the WRDSB Corporate Website. It is a requirement by the Ministry that the Special Education Plan Checklist is completed yearly. A request was made to see if anyone in SEAC would be interested in working with Cindy Benedetti throughout the year to review the plan and provide the best feedback.
